Whereas, the seniority of Mr Vijay Kumar Sawhney, Executive Engineer figured at 22-A i.e. below Mehraj Krishan Dhar and above Mushtaq Ahmed Naqeeb of the final seniority list of Executive Engineer (Civil) of PW(R&B) Department issued vide Government Order No. 390 – PW(R&B) of 2016 dated: 27.12.2016.

Whereas, in this regard, the department issued a notice vide endorsement No PW(R&B)/HRM/13/2011-III Dated: 31.12.2020 for inviting objections; and

Whereas, the department has received no objection, therefore, the seniority position assigned to Mr Vijay Kumar Sawhney is now treated as final.
