Instead of

"Two years Draftsman Training Course Certificate/Diploma in Civil Engineering from Govt. Recognized Institute" for Draftsman (Civil),UT Cadre item No.132 advertised in Notification No. 05 of 2020 and

"Two years Draftsman Training Course Certificate/Diploma in Mechanical Engineering from Govt. recognized Institute" , for Draftsman (Mechanical) UT Cadre item No.133 advertised in Notification No. 05 of 2020.
